### QUESTION 1

You deploy an Office Communications Server (OCS) 2007 R2 Standard Edition server on the network. All employees in the company use Microsoft office communicator 2007 R2 and Microsoft Office Live Meeting 2007.

Live Meeting users report that slide animations in Microsoft Office PowerPoint 2007 presentations do not display when they upload the presentation files.

You need to ensure that slide animations display correctly.

What should you do?

- A. Request that the users install the Conferencing Add-in for Microsoft Office Outlook.
- B. Request the users to save the presentation files in the Microsoft Office PowerPoint 97-2003 format.
- C. From the Meeting policy for the Live Meeting users, select the Enable program and desktop sharing check box.
- D. From the Meeting policy for the Live Meeting users, select the Use native format for PowerPoint files check box.

### Question 2

You have an office communication server 2007 R2 infrastructure that contains an Edge Server named Edge1.Contoso.local.

The subject name in the Access Edge server role certificate is Sip.Contoso.com.

All users run Microsoft office Communication 2007 R2 to connect to the OCS servers.

Some users are configured as remote users.

You plan to deploy 10 additional remote users by using office communication manual configurations.

You need to identify the external server name that must be set in office Communicator on the client computers of the remote users.

Which name should you identify?

- A. Edge1.Contoso.com:5061
- B. Edge1.Contoso.local:443
- C. Sip.Contoso.com:443
- D. Sip.Contoso.com:5062

### Question 3

Your company has an office communication server (OCS) 2007 R2 infrastructure.

You need to create a response Group work-flow for the help-desk users.

Your solution must ensure that each user can sign in and sign out.

Which two actions should you perform?

- A. Create and configure a route.
- B. Create and configure a custom tab for the office communication client.
- C. From the properties of the Response Group group, set the agent participation policy to formal.
- D. From the properties of the response Group group, set the agent participation policy to informal.

#### **Question 4**

Your company has office communication Server 2007 R2 deployed and configured to accept voice calls from a PBX.

You need to provide a user with the ability to receive calls from the PSTN by using Microsoft office communication 2007 R2.

- A. From the user's other options, Select the Enable remote user access, and then select the enable federation check boxes.
- B. From the user's telephony options, select the Enable Remote call control check box, and then enter SIP address in the server URI box.
- C. From the users Telephony Options, select the enable remote call control check box, and enter the user's telephone number in the Line URI box.
- D. From the user's telephony options, select the Enable Enterprise voice check box, and then enter the user's telephone number in the URI.

#### **Question 5**

You have an office Communication server (OCS) 2007 R2 infrastructure, all users run Microsoft office communicator 2007 R2.

A user named user2 is configured as a delegate for a user name user1.

You need to ensure that user2 can initiate and receive calls on behalf of user1.

What should you do?

- A. Configure User1 as a delegate of user2.
- B. Modify the access level for user1 on the computer of user2.
- C. Install the Microsoft Office Live Meeting client on the computer of user2

D. Install the OCS 2007 R2 Attendant console on the computer of user2.

**Question 6**
